- Highly flexible when laying and impervious to all types of soil.

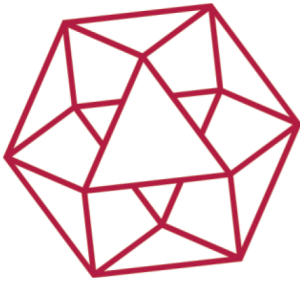
