## **ROOFLINE WARRANTY**

- 1) Pipelife Ireland Solutions Ltd performance guarantee is for 10 years for colors and 20 years for white from the date of installation, however this will only apply if the installation in question meets the following terms and conditions
  - The installation has been fitted exclusively with Pipelife Ireland Solutions Ltd products (no mixed systems).
  - The system has been installed in accordance with Pipelife Ireland Solutions Ltd installation and technical guide.
  - The installation excludes any form of coating, paint or other surface treatments.
  - Defects are notified to Pipelife Ireland Solutions Ltd in writing within 3 months of their appearance together with a proof of purchase.
  - Details and proof of installation date must be furnished to Pipelife Ireland Solutions Ltd.
  - The defects are examined, and remedial approval has been given by Pipelife Ireland Solutions Ltd Technical Dept.
  - The installation is situated within Ireland, the UK or the area of mainland Europe defined by the area north of an east-west line which passes through Paris, France.
- 2) The Pipelife Ireland Solutions Ltd guarantee applies to defects in products appearing within the guarantee period which consists of warping, splitting, cracking, or discoloration, which in the case of roofline profiles and mouldings do not conform with the colorfastness and weathering criteria as defined within BS7619 or in the case of rainwater profiles and mouldings, do not conform with the colorfastness and weathering criteria as defined in BS EN 607 and BS EN 12200.
- 3) The guarantee does not apply to any of the following
  - Products that have been abused or adulterated which include malicious damage, exposure to solvents or inappropriate cleaning products, aggressive industrial environments, abnormal weather conditions or exposure to annual solar radiation that exceeds 80 Kilolangleys.
  - Fair wear and tear, normal ageing and damage caused by external physical agents.
  - Performance outside the scope of BS 7619.
  - The application of any coating, paint or surface treatments will void the guarantee.
  - Pastel colors such as carmel, sand and grey are not covered by this guarantee.
- **4)** The Pipelife Ireland Solutions Ltd liability under the guarantee is limited at their discretion to free issue replacement or repair of any defective materials. The guarantee is given subject to Pipelife Ireland standard terms and conditions of sale.
- **5)** Pipelife Ireland Solutions Ltd will not be responsible for consequential loss of any kind.
- **6)** This guarantee does not affect the statutory rights of the customer.
- 7) The guarantee shall be interpreted only in accordance with Irish law and subject to the jurisdiction of the Irish Courts in respect of all installations.
